AIR ARRANGEMENTS THROUGH CELEBRITY

When you purchase your air arrangements through Celebrity Cruises, you can expect the following:

Round-trip air transportation to San Diego and from Ft Lauderdale.

Airport Greeting: You will be met at the airport by a Celebrity representative who will escort you to your group transportation vehicle.

Ground Transportation from your arrival airport to the pier and from the pier to your departure airport and baggage handling from the plane to the ship and back.

When making your air travel bookings with Celebrity you can expect:

Common flight arrangements for guests staying in the same stateroom, so long as guests are booked at the same time, for travel from the same gateway city (based on airline availability).

In most cases, no more than one connection from your gateway city.

E-Tickets are available for your convenience for selected carriers.

To obtain your flight itineraries as much as 60-days prior to cruise departure.

Generally, air transportation will be arranged to allow for same day departure. However, guests may be required to travel on red-eye flights or arrive up to two days before sailing. Guests may be required to make connections with different airlines. Celebrity reserves the right to select the carrier, flights, routes and layover city (if any).

PERSONAL FUNDS

All goods and services purchased on board must be charged to your Celebrity Cruises Passenger Account. Presenting a major credit card or cash deposit during embarkation will guarantee your credit line. Once on board, you need only present your authorized Celebrity Cruises ID Card and sign for all purchases. No other form of payment is permitted. Currency aboard ship is U.S. funds. At the end of your cruise you will receive an itemized bill which you may settle at the Accounts Office with cash, personal check, Traveler's Checks, American Express, Discover Card, Visa or MasterCard. Safe deposit boxes are available at no charge at the Purser's Office.

DRESSING FOR DINNER

There will be three formal nights (jacket and tie for gentlemen) and ten casual nights (slacks and shirts with collars). No blue jeans, tank tops or t-shirts in the dining room after 5:30 pm. Women may wear cocktail dresses, pants suits or slacks.

CRUISE PAYMENTS, DEPOSITS AND CANCELLATION

If you are paying by check, the final payment for this cruise is due on September 15, 2010. Credit card final payments are due on October 1, 2010. Cruise reservations will be held for 7 days from time of booking to allow time for deposits to arrive in our office. Written confirmation will be mailed after receipt of deposit. ALL CHANGES TO THE ORIGINAL RESERVATION FORM MUST BE MADE IN WRITING. This includes changes in air travel dates, tour changes, dining room requests and credit card changes. CABIN PRICES QUOTED IN THIS BROCHURE ARE THOSE IN EFFECT AT THE TIME OF PRINTING, THE RIGHT IS RESERVED TO INCREASE THE PRICES AT ANY TIME UP TO THE DATE OF DEPARTURE.
