AIRFARE ADD-ONS

Holland America offers a Fly Cruise Plan. When your airfare is arranged through Holland America Line, you are automatically enrolled in their Fly Cruise Plan, a program which entitles you to a host of benefits:

■ **FLIGHT DELAY ASSISTANCE** If your flight is delayed, Holland America Line will make sure someone is at the airport to meet you and help you with your luggage.

■ **FLIGHT CANCELLATION ASSISTANCE** If your flight is cancelled or a revised schedule no longer connects to the ship or tour, Holland America Line will alter your ticket at no charge; if necessary, they will even rebook you on an alternate airline.

CONDITIONS

1. At the time of ticketing, Holland America Lines will use the carriers, routing and fare structure of its choice based on lowest applicable fares, subject to airline rules and regulations. Holland America Lines accepts no responsibility for obtaining seat assignments. All fares are non-published contract fares and as a rule may not qualify for frequent flyer awards.

2. Air arrangements which deviate from their published cruise and land packages may be requested in writing no later than 120 days prior to departure. A non-refundable service charge of \$50 per person plus any additional air cost applies for each deviation. All deviations are subject to availability; gateway deviations are not permitted. Airline tickets cannot be changed on board ship.

3. For any flight or ticket changes made within 75 days of departure, there will be a non-refundable \$50 per person service charge. The airlines may also charge an additional penalty for these changes. These costs are the responsibility of the passenger.

4. Tickets issued by Holland America Lines are refundable only to Holland America Lines.

PERSONAL FUNDS

All goods and services purchased on board must be charged to your Holland America Line Passenger Account. Presenting a major credit card or cash deposit during embarkation will guarantee your credit line. Once on board, you need only present your authorized Holland America Line ID Card and sign for all purchases. No other form of payment is permitted. Currency aboard ship is U.S. funds. If you are paying by check, the final payment for this cruise is due on September 15, 2008. Credit card final payments are due on October 1, 2008. Cruise reservations will be held for 7 days from time of booking to allow time for deposits to arrive in our office. Written confirmation will be mailed after receipt of deposit. ALL CHANGES TO THE ORIGINAL RESERVATION FORM MUST BE MADE IN WRITING. This includes changes in air travel dates, tour changes, dining room requests and credit card changes.
